Dues

The board has been in discussion concerning the structure of our membership dues. While the club constitution stipulates that spouses, students, seniors and associates shall pay one half (1/2) of the regular dues, we have discussed eliminating the confusing "repeater support" of \$6.00 and simply having 2 rates for all memberships. There are two (2) proposed rate structures that will keep revenue from dues about the same. They are as follows:

Full membership: \$24.00 All Others: \$12.00

<u>OR</u>

Full Membership: \$30.00 All Others: \$15.00

January 8, 2010

At 8:01 p.m. the club's new president, Duane KD8AUY, brought the business meeting to order with music to wake us up, proposing more energy at our meetings. Looking for uses for Christmas gifts from children (politician books, etc.). Duane asked members to do the best we can and have a good year, and asked for presentation suggestions & volunteers. Ron KC8YVF acknowledged that he would have a presentation later, and Joe K8CQF may also present in the future. Duane also requested that board members sit up front during the meetings 'in case of shoe throwing.' Welcomed all present with more music in the background during introductions; 20 in attendance.

Pledge of Allegiance Announcement: Will review Dues tonight

Secretary's Report:

Mike N8XPS submitted minutes, as well as year in review with the Harmonic.

Motion to accept as minutes as presented made by Gordy KC8YVD, with a second from Jeff KC8BDQ and unanimously passed by all in attendance.

Treasurer's Report:

Judy KC8BYI presented the year end summary for January through December of 2009. Motion to accept by Dave WB8LZA; second by Ron KC8YVF; unanimously passed by all in attendance.

Discussion: Do we do any charitable activities with the balance?

Care Breaks, Katrina, Red Cross, books donated to libraries, science fair, scholarships (no applications yet). Duane KD8AUY suggested donations of non-perishable goods.

Monthly Report presented by Judy KC8BYI, which included an extra charge of \$42 for the club's P.O. box, which Judy paid for with her personal account last February.

Motion to accept by Emmett W8EAB; second by Gordy KC8YVD; passed with no opposition.

Old Business:

Information and discussion regarding club dues. Judy presented two options recommended by the board, which will simplify the process and include repeater fees as an all-inclusive fee. Members will vote at February's general meeting.

Current Dues Schedule:

\$15.00 Full Membership
\$7.50 ½ Price Membership (seniors, spouses, students, disabled & associate members)
\$6.00 Repeater Fee

Option 1:

\$24 Full Membership

\$12 ¹/₂ Price Membership

Option 2:

\$30 Full Membership\$15 ½ Price Membership

Discussion:

Emmett W8EAB: Both are good options. Should be included in next month's newsletter; editor will have the information to publish.

Joe K8CQF: Repeater dues would go away. Within the last 2 years, nobody has paid repeater fees only. Suggested adding a generic donation line item, as next month we should have more information on the club's 501c3 status.

Jeff KD8IOK: These options make things easier for the treasurer by eliminating change, using whole dollar amounts.

Judy KC8BYI: In the past, members joining during a partial year have paid the full rate rather than a pro-rated fee.

Jeff KC8BDQ: Do the by-laws specify the number of meetings a person can attend before becoming a member?

Dave N8ERL: Believes it is 3 meetings "free," then membership is required. However, this rule has not been enforced.

Ron KC8YVF: Does increasing fro \$21 to \$24 cause any hardship? The intent is to simplify the process, but minimize hardships.

Jeff KD8IOK: Votes for a family rate (with a wink).

Judy KC8BYI: Constitution allows the board to reduce or waive dues for specific hardship cases.

Joe K8CQF: Suggested considering time contributions as "in kind" equivalent to dues?

Jeff KD8IOK: Maybe if we include the officers' time as "in kind" more people will volunteer for those positions.

Mike N8XPS: For comparison, national membership for the ARRL is \$39.

Joe K8CQF: If members renew their ARRL membership through the club, does the club still get \$1 back?

Judy KC8BYI: That was suspended for a while but may now be back. However, there was a long delay for membership to become active that way. Judy will check into it.

Jeff KC8BDQ: Suggested "SVARA Bucks" for participation and time contributions.

Dave N8ERL: Suggested moving along the meeting, as it was getting late.

New Business:

Ron KC8YVF reminds members that K9 One will be presenting at the next general meeting (February 5). This will be a demonstration mainly for the ARES group, but should be interesting for everyone.

Ron KC8YVF: Last year the club participated in the Hobby Fair at Hemmeter High School. This event will be Saturday, January 30 from 10:00 a.m. to 2:00 p.m. with setup at 9:00 a.m. Will need to track down the mice for CW; Judy KC8BYI will contact Rob KC8IJN.

Ron KC8YVF: FCC rules on Ham operation use during drills & exercises:

Ham operators cannot conduct business over amateur radio, even when regular communications are down. An organization must apply for a waiver to use an "on the clock" operator in an exercise.

Committee Nominations

<u>SkyWarn</u>

Suggested changes for Rosien:

Jeff KB8SWR asked about changing the phone from a voice line to DSL.

<u>Benefits:</u> Cheaper (\$19.95/month), allows for constant Echolink, ,IRLP, VOIP, can control the repeater via computer. Will interface with the current repeater.

<u>Concerns:</u> Repeater maintenance depends on an "up all the time" PC. What happens when the computer goes down? Ron KC8YVF will have the ability to control it remotely. How will this affect /benefit club members?

<u>Recommendations:</u> Jeff KC8BDQ recommends that we wait until the Antenna & Radio at Rosien is worked out. Cannot jeopardize the Auto Patch capability.

<u>Research:</u> Jeff KB8SWR will conduct an engineering study – looking into whether a new card is needed. Verify whether the quoted DSL rate is for an individual or a business (club will be considered a business). Judy KC8BYI requested a complete report in writing for the Board to review.

Summary of Requirements to be discussed later with more info:

- Lower cost
- Keep current capabilities
- Possibly adding capabilities

Old Business:

Jeff KC8BDQ received several returned Christmas invitations in the P.O. Box. Pass these and any more along to Mike N8XPS, who will edit the database and pass along to Rachelle KD8UOK.

Reviewed suggestions from the general meeting:

Consensus says that SVARA Bucks would be too much work, not enough incentive, and risks losing money.

Are dues a taxable write off donation?

Jeff KD8IOK agrees that offering free membership for officers could bring more volunteers, and possibly promote more accepted nominations in future elections.

Voting on Dues Changes

Paper ballot with 2 options, rather than a show of hands.

Must have a 25% quorum to validate the vote.

Considered offering an absentee ballot, but decided against it; as it would be too difficult to manage, and it is likely that a majority will be in attendance at the meeting.

Meeting adjourned at 8:54 p.m. via motion by Emmett W8EAB, and second by Jeff KC8BDQ.
