### SVARA Board of Directors Meeting February 18, 2009 Texan Restaurant on State Street

Meeting called to order at 7:58 pm. Present were KC8BDQ, W8EAB, KC8BYI, W8LPV, N8XPS, KC8YVF, and KD8IOK

Secretary's report: Motion made to accept minutes as presented in the Harmonic with two corrections was made by KC8BDQ and seconded by W8LPV.

Treasures Report was presented at General Membership Meeting.

KC8BDQ to make contact with Mark Torregrossa the Chief Meteorologist with WEYI about coming making a presentation at a General Membership Meeting.

W8LPV presented to the board a letter and policy statement from the ARRL on "Mobile Amateur Radio Operation" prepared for the City Council of Saginaw.

KC8BYI reported on the investigation of changing to higher rate accounts. Chemical Bank considers SVARA as a business. Bank policy would require a balance of \$15,000. Paperwork to transfer signatory from KC8BDQ to W8LPV processed after meeting.

The dead line for applications to host Care Breaks set back 2 weeks.

KC8YVF updated on the process of coordinating the link frequency for the repeater. Efforts by N8XD have determined the frequency is claimed by the Livingston County repeater. With the SVARA repeater being crystal controlled, it makes it difficult to change the frequency. We are possibly interfering with the Fenton area repeater. They will listen on frequency for the next year. We may have to alter power or antenna at Davenport site.

We were also updated on Emergency Coordinators meetings. The local meeting will have further discussion of the replacement of antennas to Rosien Towers. Tim Genovese is on board and offered assurances that the antennas will be returned. Planned configuration will have two 30ft towers attached to the north and west side of the buildings with ARPS and 440 on one and ATV on other. N8ERL offered two 10ft tower sections; we will begin looking for further donations to save on needed purchases. Scheduled training for the club in March will be for Net Control Station. Ideas for project nights are Packet Kits and HT programming bring your manual. The condition of the Saginaw County trailer was checked on by KC8YVF. Related equipment is to be moved from the court house to the hanger of N8ERL.

The results of the District EC meeting will provide SVARA with 2 FM Transceivers 1 to be used for packet in 911. The packet station will require a separate club call sign K8DAC has the maximum allowable operations attached to it, and will not be effected.

March 7<sup>th</sup> and 8<sup>th</sup> from 0000-2400 UTC will be the ARRL International DX Contest. A mass e-mail will be sent to inquire who would be interested in operating from the club station.

NOAA Skywarn Training will take place at the Covenant Cooper Theater on April 9th.

ARES public service hours form changed to include mileage. Technician License class planned for an undetermined date in May. MS Walk has been added to ARES calendar on the 2<sup>nd</sup> of May.

An update of 501 c 3 status was given. KC8BYI announced a change to the charter that will be discussed with our lawyer.

Motion to adjourn made by KD8IOK seconded by W8EAB the meeting came to a close at 9:05 pm.
