General Meeting Minutes American Red Cross Building

June 3, 2016

The meeting was called to order by Mike KD8MMH, with 20 members and 5 guests present.

Ron KC8YVF, made a motion to accept last month's meeting minutes as published in the harmonic news and was seconded by Tom N8EUI. The motion passed.

Duane KD8AUY, gave the Treasurer's report. Emmett NE8B, Made a motion to accept the report which was second by Gordy KC8YVD.

Minnie, reported on upcoming ham swaps. Mike KD8MMH, mentioned the Midland club was offering us a free table at this year's Midland ham swap. Mike N8XPS, mentioned an upcoming auction at the Alcona Fairgrounds. Emmett NE8B, reported on the Frankenmuth MS walk. He said it went well and the weather was good. Mike KD8MMH, reported on the Midland MS walk and the recent care break, both of which went well. He also noted there would be no July meeting and the August meeting would be our annual ice cream social.

Ron KC8YVF, reported on the Saginaw County Simulated Emergency Training and the upcoming Ares training. For the SET in general, some things went well some did not. On the hand side of things everything was good although getting signals out of MBS was challenging. The state simulated a loss of their 800 MHz system and was able to switch to ham communication without incident. We had good comments from the MMR representatives and others. The DMR radios worked also well.

At this point Mike KD8MMH, turn the discussion towards ongoing projects. He mentioned that \$1500 has already been approved for the tower project which is currently on hold. Ron KC8YVF, and Jeff KB8SWR, discussed and answered questions about the current repeater project. A question was asked about the timeline for the project and if approved at this meeting could be completed by November. Jeff KB8SWR, said this would be a steppingstone to a more modernized system. Dave W8DW, mentioned that the current voter is on its last leg. Several people raised questions about coverage of the new system versus the current system versus using the fusion repeater as a single site. In general, coverage of the new system versus the current system will be at least the same and should be better. Using the fusion repeater as a single site may provide better coverage centrally but would not provide coverage to the same geographical locations as the current system. The need to test and for club members to use, the fusion repeater so we can better gauge the performance of the repeater was also mentioned. It was also mentioned that for a lot of club members all of this is very confusing and it would be helpful if there was more information available so everyone could understand what is going on.

Duane KD8AUY, made a motion to postpone the vote for additional funds until August, to allow time for testing the fusion repeater and to allow club members time to learn about the ongoing project and the current system. This motion was seconded by Mary WB8LZA, and passed with one nay.

The motion to adjourn and was made by Emmett NE8B and seconded by MaryWB8LZA.
