+++ New Canadian Driving Laws Affect Visiting Hams +++

In looking into the impact of the new Ontario law that requires operation of mobile, two-way radios to be hands free, it was learned that Quebec also has a law that impacts Amateur Radio. In Quebec, driving while holding a hand-held device with a "telephone function" is outlawed. This is true even though the telephone function is not being used. There is no exemption for amateurs.

In Ontario, the new, hands-free law applies immediately to non-residents. Ontario residents are granted a 3-year grace period before the law is enforced. These new laws appear to be consistent with Canadian-US treaty regarding Amateur Radio. Finally, Manitoba has passed a hands-free law that is not yet in force. Enforcement will begin only after detailed regulations have been completed.

Thanks to Marsha Fleming, N8FE of Oak Park, MI for obtaining much of this information from Richard Ferch, VE3KI of Ontario. Rich is Vice President, Regulatory Affairs of the Radio Amateurs of Canada (RAC). The RAC is the national organization for radio amateurs in Canada.
