Secretary's Report:

Motion to accept May minutes as presented in the Harmonic made by Gordy (KC8YVD) with a second by Joe (K8CQF).

Treasurer's Report:

Was presented by Judy (KC8BYI). Motion to accept made by Emmett (W8EAB) then seconded by John (KC8WZM).

Old Business:
