Topic of Discussion: Club Insurance.

The old insurance company Mercer is no longer offering insurance to Ham Radio Clubs and has suggested using the new insurance company Philadelphia.

Insurance for 2023 was \$407.07 through Mercer.

The Philadelphia insurance company did not answer Tom's request for a quote. They required additional information before one could be provided.

ARRL insurance would provide the same coverage as Mercer for a cost of \$300. This is just for liability and not for equipment (same as Mercer).

Equipment coverage through the ARRL would be \$1.40 per \$100 worth of equipment.

The board accepted a motion from Rick KC8VOA and seconded by Mike KD8MMH to move ahead with the insurance from the ARRL.

Tom N8EUI will check to see if the Medical coverage can be increased from \$10,000 to a higher amount.

Tom will also check on equipment coverage and if that can also cover the club trailer.

Meeting was adjourned at 7:55 pm
